What Is Sponsorship?

Sponsorship is an agreement between two parties where one company provides products or financial support to another individual or company in exchange for their marketing and promotional efforts (print, television, online, etc.).

A potential sponsorship recipient should be familiar with our products, company philosophy and history. As a sponsorship recipient, you become a representative of Auto FX. Not only should you conduct yourself accordingly, but you should also be able to promote our company's products and services in a knowledgeable manner.

Terms

The duration of the sponsorship agreement is valid for one calendar year (Gregorian Calendar System) from the date of signing. At the end of the term, both parties are free to renegotiate terms. Details of the agreement are dictated on an individual basis. Some issues to be addressed (but not limited to): logo size and placement, event attendance, and media coverage.

Auto FX requires that all products received during sponsorship be installed 'in house' to insure quality of work will not be compromised and up to standards.

The sponsorship recipient will defend and hold harmless Auto FX, its parent company, subsidiaries, and affiliated corporations and their respective directors, officers, employees, agents, and successors from and against any and all claims, damages, liabilities, losses, government proceedings, and all costs of expenses including attorney fees and costs of suit arising out of any personal injuries or claims in connection with any racing or driving activities.

The sponsorship recipient will understand that under no circumstances are the details of sponsorship to be disclosed. Failure to do so will result in sponsorship termination.

Auto FX may terminate the sponsorship agreement if the sponsorship recipient engages in conduct or commits an act which would endanger the good name and reputation of Auto FX or cast Auto FX in an unfavorable light, or any way bring Auto FX into disrepute anywhere in the world.

In the event that the sponsorship recipient is unable to fulfill the obligations outlined in the sponsorship agreement, the sponsorship agreement is void. In the event of a voided sponsorship agreement, the sponsorship recipient must pay the full retail price of all parts received and labor provided.

Sponsorship Proposal

A proper sponsorship proposal should include:

- The following application form filled out in full
- A brief introduction of yourself, company or team
- Vehicle make, model and year
- Vehicle engine combination (hybrids, engine swaps, etc)
- Aftermarket products and modifications currently on vehicle
- Current sponsors
- Current photos of the vehicle
- Future Goals
- Event attendance schedule

All the above should be presented in a professional format. Failure to include any of the above information will eliminate your proposal from being considered. Please note that any photographs you provide will become property of TGR GarageWorks Ltd. (Auto FX) and will not be returned.
